Madera County 2004 Regional Transportation **Plan Update**

The Madera County Transportation Commission (MCTC) is in the process of updating the Madera County Regional Transportation Plan (RTP) for adoption by the MCTC Policy Board in September The RTP is a comprehensive 2004. long-range planning document that is designed to accommodate the fiscal and

infrastructure demands of the multi-modal transportation system over the next 25-year period. The RTP ensures that the County's transportation system policies and programs safely and efficiently

accommodate the population growth and land use patterns envisioned in the General and Area Plans of the cities of

Madera and Chowchilla and County the Madera.

The RTP must reasonably project the future Federal, State, and Local funds dedicated for transportation purposes provide a project specific plan to allocate the

funding in a financially constrained manner. Since the infrastructure needs of the County significantly outweigh the

financial resources available for transportation projects, an unconstrained list of projects is included in the plan. The financially unconstrained list of projects may be implemented as special funding opportunities become available. The RTP is required to have a Policy Element that reflects the transportation

policies, goals, and objectives of the region; Action an Element that identifies programs projects to implement RTP; and Financial Element that balances the cost of planned projects against the available projected revenues.




REVENUES BY SOURCE

Due to the recent State Budget impacts on transportation funding and the failure to pass an extension of Measure "A" in November 2002 (a local 1/2 cent sales tax), the

revenue projections in the 2004 RTP have been notably decreased as compared to the financial outlook in 2001. The State Transportation Improvement Program (STIP) may not have the funding capacity to program new projects until the year 2010. The extension "A" Measure was

fundable projects will be reduced in the 2004 RTP Update. MCTC projects that \$304.9 million will be available to Madera County during the 25-year planning horizon for transportation projects.

The delivery of transportation projects and in particular the regional-scale capacity increasing projects is a complex and time consuming process involving project design, engineering, environmental approvals and right of way acquisition. All of which must be completed prior to beginning project

construction. Larger transportation projects can take as long as ten years to deliver. Smaller projects can sometimes be accomplished in three to five years. Funding resources are limited, somewhat uncertain, and only available on an incremental basis. The time needed for project development coupled with the uncertainties inherent in the funding process dictate that projects be prioritized for delivery. The MCTC Policy Board has directed staff to produce a regional prioritized list of projects for inclusion in the 2004 RTP Update.

MCTC has retained VRPA Technologies, Inc. to develop an objective technical methodology to determine a regional ranking for each project based upon a cost-benefit analysis. Madera County Traffic Model forecasts were used to predict traffic volumes on the regionally significant road system associated with the housing and employment projections for the year 2030. The corresponding capacity deficiencies were determined and a list of projects was identified to correct the deficient transportation network totaling \$560 million. However, the financial element projections indicate a maximum of \$93.5 million for capacity increasing projects funded by the STIP program. The Cities of Madera and Chowchilla and the County of Madera have also nominated \$32.6 million in local street and road rehabilitation projects for inclusion in the 2004 RTP

Because the RTP plays such a major

role in establishing goals and objectives and guides the implementation of infrastructure improvements, important that this update is conducted in a public forum. MCTC has scheduled a series of Public Workshops in order to better inform the public of the 2004 RTP Update process and to solicit input from various community groups, stakeholders, other interested parties, and the general public. Anyone that wishes to have their comments considered in the development of the draft 2004 RTP Update is invited to attend one of the workshops and/or submit their comments in writing to the MCTC. The Executive Summary of the 2001 RTP is currently available online http://www.maderactc.org/public.html. A draft of the 2004 RTP Update will be available for public review and comment 30 days prior to adoption by the MCTC Policy Board in July 2004 following a public hearing on the RTP.

Meeting Public Transit Needs: Evolving Transit Services in Madera County

Madera County transit services have come a long way since the days of small demandresponsive transit services---Madera Dial-A-Ride, Madera County Senior Bus, and Escort Program. County residents now are also served by fixed-route Madera Area Express

(MAX), inter-city Madera County Connection (MCC), and Chowchilla Area Transit Express (CATX).

Expansion of transit services in the past five years has greatly eased the mobility needs of many Madera

residents. In 2001 Madera County initiated MCC, an inter-city transit service, to and from Downtown Madera, Eastern Madera County, Chowchilla, Madera Community College, and Valley Children's Hospital of Central California. MCC added service to

Ripperdan, La Vina, and Eastin Arcola in 2002. Last year, the Madera County Escort Program was expanded to serve the Madera Ranchos. In 2002, the City of Madera added a new MAX route to provide riders with access to Howard Road businesses and other destinations.

Cleaner Air Through Carpooling

As the price of gasoline increases and the quality of Valley air decreases, commuting to work or school alone begins to make less sense. Enter carpooling. Not an altogether new solution, it has never-theless been shelved in the back of people's minds, locked into the past with elementary schools and station wagons. However, what made sense then, still makes sense now. By carpooling with friends or coworkers, the roads, the air, and the all-

important wallet, get a muchneeded break. More people per car means less cars on the roads, which leads to less congestion, pollution, and fuel burned. Aside from the obvious benefits, consider that putting fewer miles on your car translates to a slower rate of depreciation and longer intervals between maintenance.

The distance traveled on one gallon of gasoline is also maximized with each additional passenger per car. When it comes to transporting more than one passenger,

the much-loved miles per gallon (mpg) figure is not as relevant as the amount of people miles per gallon. For example, an economy car, driven alone, covering 30 miles per gallon is a miserly feat, but it can fall behind the oversized SUV getting 15 mpg and transporting four passengers. The math: econo-car—30 people miles/gallon; SUV—60 people

miles/gallon. Granted 4 people per vehicle nowadays is the exception rather than the norm, the potential benefits certainly exist

There are a number of options available to fill a vehicle and to create a successful carpooling program. The first option is simply talking with coworkers and/or friends who have similar originations and destinations. Work out which

days work for everyone, keeping in mind that even one day of carpooling per week makes a difference. Some ideas to consider are to create a back-up transportation plan in case of an emergency and also work to lump errands into fewer trips. Another option is Valley Rides for Central California. This online carpool match system is a joint venture between California State University of Fresno and the Council of Fresno County Governments to create potential carpools

through individual commute characteristics. Currently, over 467 people are successfully commuting in carpools using Valley Rides, 17 of which either start or end their trip in Madera. For more information or to find a potential match, visit www.valleyrides.com. The benefits are significant and the effort is quite elementary.

Additional Steps To Help Clean Our Air:

- Try bicycling, walking, or taking public transit to work. Even one day per week will help!
- Keep your tires properly inflated. Underinflated tires can decrease fuel efficiency by 5% or more as well as cause premature wear.

Progress to improve transit services throughout the County continues. The City of Madera is installing new benches and shelters at key bus stops and is seeking planning funds to evaluate feasible options to expand its transit facilities to address overcrowding at the Downtown Intermodal Center. Madera County is seeking funds to develop a Strategic Transit Plan to provide the County with a fiscally sound and comprehensive plan for delivery of transit services over the next five to ten The proposed study will help transit needs, including identify operating, capital, maintenance, and financial requirements. The City of Chowchilla recently expanded the capacity of CATX.

The MCTC annual unmet transit needs public hearings provide an

opportunity for residents to express their transit needs. While public transit will continue to evolve with the needs of our region, a major challenge of local jurisdictions will be to maximize limited funding resources through regional and inter-regional cooperation and collaboration and, where feasible, to integrate services for greater economies of scale in delivering transit services
